## Product

The My Select life policy, is manufactured by Scottish Friendly Assurance Society Limited ('Scottish Friendly'). The investment option is the International Company Bond fund, which is manufactured by Scottish Friendly, and links to the Legal and General Fixed Interest fund. ## What is this product?

What are the risks and what could I get in return?


The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7 , which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level and poor market conditions could impact our capacity to pay you.

The product does not include any protection from future market performance so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment. However, you may benefit from a consumer protection scheme (see section 'What happens if we are unable to pay you'). The indicator shown above does not consider this protection.

## Performance scenarios

When money is invested it is exposed to risk, meaning that you may get back less than was invested. The outcomes experienced will come from the returns of the investment(s) which are held by the fund. This fund invests in Corporate Bonds (loans to companies) from around the world with a large proportion of these being from UK based companies. The funds performance will be dependent on the credit worthiness of the company bonds purchased by the fund manager. Movements in long-term interest rates and the movement in currency exchange rates will also impact the fund's performance. With a large proportion of the fund invested in the UK, the UK's long term interest rates and the relative value of sterling to other currencies will have a significant impact on the fund's performance.

## What could affect my return positively?

The credit worthiness of the company issuing the bonds held within the fund will have a significant impact on the fund's performance. With a large proportion of the bonds from UK companies the long-term interest rates within the UK will have an impact on the fund's performance.

## What could affect my return negatively?

A fall in credit worthiness could lead to companies not being able to repay their loans and would have a significant impact on the fund's performance. With a large proportion of the bonds from UK companies, changes to the long-term interest rates within the UK may have an impact on the fund's performance. Under severely adverse conditions returns of the fund could be negative meaning investments in the fund could fall substantially in value. Your maximum loss would be that you lose all of your investment.

## What happens if Scottish Friendly is unable to pay out?

If you buy a policy with Scottish Friendly and we cannot pay the full amount due, you may be entitled to compensation under the Financial Services Compensation Scheme. The maximum level of compensation for claims against firms declared in default is $100 \%$ of the claim with no upper limit.

## What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest $£ 10,000$ at outset. The figures are estimates and may change in the future.
