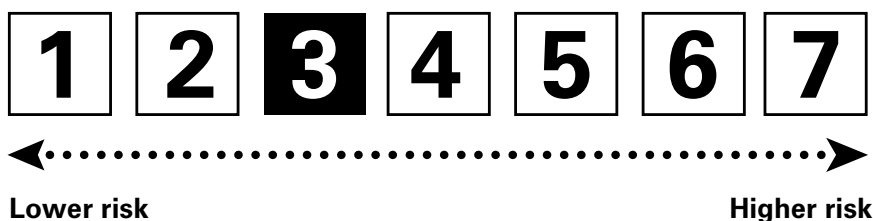
Product

The My Choice life policy, is manufactured by Scottish Friendly Assurance Society Limited ('Scottish Friendly'). The investment option is the International Company Bond fund, which is manufactured by Scottish Friendly, and links to the Legal and General Fixed Interest fund. What is this product?

Type	The product is a unitised whole of life assurance policy held within the Scottish Friendly ISA with a chosen investment option of the International Company Bond insurance fund.
Objectives	My Choice is a unit linked whole of life assurance policy that aims to help your investments to grow tax-efficiently. The chosen investment option of an International Company Bond fund aims to generate capital growth by investing in bonds issued by companies throughout the world. It invests in an underlying fund with the intention of actively managing a portfolio of bonds issued by companies, a large proportion of which will be UK based companies. The funds performance will be dependent on the credit worthiness of the company bonds purchased by the fund manager, the movement in long-term interest rates and the movement in currency exchange rates. Tax treatment depends on individual circumstances and can change in the future.
Maturity	This product does not have a maturity date. The recommended holding period is at least 5 years. Scottish Friendly cannot unilaterally terminate this product.
Intended retail investor	This product is intended for investors who are prepared to take on a medium-low level of risk, linked to a portfolio of bonds issued throughout the world, selected by an expert fund manager, in a medium to long-term arrangement.
Insurance benefit	The amount payable on death is 101% of the value of units held within the policy.

What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level and poor market conditions are unlikely to impact our capacity to pay you.

The product does not include any protection from future market performance so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment. However, you may benefit from a consumer protection scheme (see section 'What happens if we are unable to pay you'). The indicator shown above does not consider this protection.

What happens if Scottish Friendly is unable to pay out?

If you buy a policy with Scottish Friendly and we cannot pay the full amount due, you may be entitled to compensation under the Financial Services Compensation Scheme. The maximum level of compensation for claims against firms declared in default is 100% of the claim with no upper limit.

What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest £10,000 at outset. The figures are estimates and may change in the future.

How long should I hold it and can I take money out early?

Recommended minimum holding period: 5 years

This product has no minimum required holding period. It is designed to provide potential growth on investments over the medium to long term, so you should expect to leave your money invested for at least 5 years. You have access to your money at all times and can make a withdrawal without penalty.
